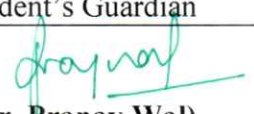
### **Subject: Constitution of Anti-Ragging Squad for the Academic Session 2026–27**

In pursuance of the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009, the directives of the Hon'ble Supreme Court of India, the guidelines issued by the All India Council for Technical Education (AICTE), the Pharmacy Council of India (PCI), the academic regulations of Dr. A.P.J. Abdul Kalam Technical University (AKTU), Lucknow, and the Government of Uttar Pradesh, the following Anti-Ragging Squad is hereby constituted for the Academic Session 2026–27.

The Anti-Ragging Squad shall function as a vigilant and mobile enforcement body to prevent ragging and maintain discipline in academic buildings, laboratories, libraries, hostels, canteens, sports facilities, institute buses and all other areas of the campus. The Squad shall conduct regular and surprise inspections and take immediate action against any incident of ragging.

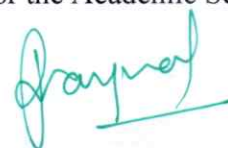

### **Functions of the Anti-Ragging Squad**

The Squad shall:

- Conduct regular and surprise inspections of classrooms, laboratories, hostels, library, canteen, buses and other vulnerable locations within the campus.
- Prevent any act of ragging and immediately intervene whenever any incident or complaint is noticed.
- Monitor interactions between senior and junior students to ensure a ragging-free environment.
- Receive information or complaints relating to ragging and promptly report all cases to the Anti-Ragging Committee and the Competent Authority.
- Recommend immediate preventive and disciplinary measures against individuals involved in ragging in accordance with UGC Regulations and Institute Rules.
- Coordinate with the Chief Proctor, Hostel Wardens, Security Section, Students' Counselling Cell and Internal Complaints Committee to ensure campus safety.
- Create awareness among students regarding the consequences of ragging through orientation programmes, counselling sessions, posters, notices and other awareness campaigns.
- Maintain inspection registers, complaint registers, surprise visit reports and Action Taken Reports for review by the Director and statutory authorities.
- The Squad shall remain vigilant throughout the academic session and shall conduct regular as well as surprise inspections, particularly during the commencement of the academic session, admission period and hostel allotment.

This Order shall come into force with immediate effect and shall remain valid for the Academic Session 2026-27 or until further orders.
