Functions of the Hostel Committee

The Committee shall:

- Supervise the overall administration, maintenance and functioning of boys' and girls' hostels.
- Ensure discipline, safety, security and welfare of hostel residents in accordance with Institute rules and UGC guidelines.
- Monitor cleanliness, sanitation, food quality, drinking water, electricity, housekeeping and maintenance of hostel facilities.
- Coordinate with the Proctorial Board, Anti-Ragging Committee, Internal Complaints Committee (ICC), Medical Officer and Security Section to ensure a safe and congenial hostel environment.
- Address grievances relating to hostel accommodation, facilities, mess management, maintenance and student welfare.
- Promote cultural, recreational, sports and community activities within the hostels.
- Conduct periodic inspections of hostel infrastructure and recommend improvements wherever necessary.
- Maintain records of meetings, inspections, grievances and Action Taken Reports, and submit periodic reports to the Director.
- The Committee shall meet at least once every month or more frequently whenever necessary. Minutes of Meetings and Action Taken Reports shall be maintained by the Member Secretary.

This Order shall come into force with immediate effect and shall remain valid for the Academic Session 2026-27 or until further orders.
