OFFICE ORDER

In compliance with the judgment of the Hon'ble Supreme Court of India, the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009 (as amended from time to time), the guidelines issued by the All India Council for Technical Education (AICTE), the Pharmacy Council of India (PCI), the Department of Technical Education, Government of Uttar Pradesh, the regulations of Dr. A.P.J. Abdul Kalam Technical University (AKTU), Lucknow, and other applicable statutory provisions, the following Anti-Ragging Committee is hereby constituted for the Academic Session 2026-27.

The Committee shall formulate and oversee the implementation of anti-ragging measures, create awareness among students, monitor compliance with statutory provisions, review complaints received from the Anti-Ragging Squad, and recommend appropriate disciplinary action against persons found guilty of ragging, in accordance with the applicable regulations.

Functions of the Anti-Ragging Committee

The Committee shall:

- Ensure strict implementation of the UGC Anti-Ragging Regulations, 2009 and the directions of the Hon'ble Supreme Court of India.
- Develop and periodically review the Institute's Anti-Ragging Policy and Standard Operating Procedures.
- Supervise the functioning of the Anti-Ragging Squad and review reports submitted by it.
- Create awareness among students, parents, faculty and staff regarding the prohibition of ragging through orientation programmes, counselling sessions, workshops, posters and awareness campaigns.
- Receive reports of ragging from the Anti-Ragging Squad and other stakeholders, conduct inquiries wherever necessary, and recommend appropriate disciplinary action to the Competent Authority.
- Coordinate with the District Administration, Police Authorities, Hostel Wardens and Student Affairs Office to ensure a safe and ragging-free campus.
- Ensure that anti-ragging undertakings are obtained from every student and parent as prescribed by the UGC.
- Monitor vulnerable locations including hostels, buses, canteens, sports facilities, laboratories, libraries and other common areas.
- Submit periodic compliance reports to the Director and maintain all records relating to anti-ragging activities, meetings, complaints and Action Taken Reports.
- The Committee shall meet at least once every semester and additionally whenever any complaint or incident relating to ragging is reported. Minutes of Meetings, Complaint Registers, Inquiry Reports and Action Taken Reports shall be maintained by the Member Secretary.

This Order shall come into force with immediate effect and shall remain valid for the Academic Session 2026-27 or until further orders.
